DIRECTIONS FOR USE:

This package contains one resin vaporizer strip impregnated with dichlorvos insecticide, in a sealed pouch to prevent vapour loss. For use, remove the strip from the pouch and suspend with the accompanying hook in an enclosed space of up to 30 cubic metres. The strip gives off a virtually odourless insecticidal vapour which will provide control of flies, mosquitoes and other small flying insects for up to four months. The strip is NOT designed to repel or kill insects instantly. Allow free air movement but hang strips away from open windows and doors where excessive ventilation may reduce efficiency. Strips should be at least 3 metres apart.

USES:

- For use in unoccupied areas. Not for use in homes except garages, attics, crawl spaces and sheds, occupied for less than 4 hours per day.
- Also for use in the following areas: animal & farm buildings, milk rooms (avoid contamination of milk or milking equipment), motels, restaurants (non-food areas only), food processing plants (non-food areas only), industrial and commercial locations, kennels, garbage storage areas and containers, and similar enclosed spaces, if areas are occupied for less than 4 hours per day.
- Also for use in cottages, cabins and trailers, if areas are to be unoccupied for 4 months following placement of strips.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN AND PETS. To avoid misuse, observe the following precautions. Wash hands after handling. Do not use in areas where the chronically ill may be exposed. Certain tropical fish and caged birds may be harmed by continuous exposure to vapour. Do not use in areas where beekeeping equipment and/or supplies are stored. Follow good sanitary practice by regular collection and disposal of dead insects.

FIRST AID:

SEE A DOCTOR or contact a Poison Control Centre **IMMEDIATELY** if poisoning is suspected.

If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If on skin, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If strip is licked, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

This product contains an organophosphate insecticide, dichlorvos, which is a cholinesterase inhibitor. Atropine is an antidote, 2-PAM may be useful.

DISPOSAL:

Do not reuse empty packaging. Wrap and dispose of empty package and used strip with household garbage.

NOTICE TO USER:

This pest control product is to be used only in accordance with the directions on the label. It is an offence under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label. The user assumes the risk to persons or property that arises from any such use of this product.
