DIRECTIONS FOR USE

APPLICATIONS OF THIS PRODUCT, OTHER THAN AS A CRACK AND CREVICE TREATMENT, ARE NOT PERMITTED.

Use a suitable bait gun applicator or hand held plunger to apply approximately 28g per 10 m² (1 oz per 108 ft. 2) applying the paste liberally in heavy infested areas and sparingly in lightly infested areas in homes, restaurants and other food and feed handling establishments: markets, schools, warehouses, offices, hotels, motels, hospitals, nursing homes, garages, grocery stores, apartment buildings, new construction, industrial plants, theaters, ships, boats, trains, yachts, camps, mobile homes, buses, zoos, kennels, military bases, libraries.

Apply the paste into seams under and behind refrigerators, stoves, sinks, dishwashers, washing machine, dryer and tubes; into openings around drains, sewers, manholes, water pipes and electrical conduits; in CRACKS AND CREVICES along baseboards and in corners of cabinets, cupboards and food closets. Remove all lower drawers in kitchen and bathroom cabinets, bedroom dressers and chest of drawers, then apply the paste into each corner of drawer wells.

ANY PASTE VISIBLE AFTER APPLICATION MUST BE SCRAPED INTO CRACKS AND CREVICES OR REMOVED.

APPLY THE PASTE IN AREAS INACCESSIBLE TO CHILDREN AND PETS.

IN NON-FOOD AREAS, including garbage rooms, lavatories, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling): Apply to baseboard areas, around water pipes, surfaces behind and beneath sinks, lockers, tables, pallets and similar areas where cockroaches hide or through which they may enter.

IN MEAT PACKING AND FOOD PROCESSING PLANTS: Apply only when plant is not in operation. No exposed meat products, ingredients or packaging materials to be left in the room and cover food handling equipment. Any treated surface that may contact meat or other food products should be washed and rinsed thoroughly with portable water after application and before re-use for food processing.

IN NEW CONSTRUCTION: Apply the paste liberally when treating large areas, such as wall voids, soffit and sub cabinet voids in new and existing construction.

STORAGE:

Store in original containers in a cool dry place. Do not store at extreme temperatures.

DISPOSAL:

Make the empty container unsuitable for further use.

Dispose of the container in accordance with provincial requirements.
