PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid ingestion and contact with eyes or skin. The use of water-proof gloves during application of the product is recommended. Wash hands with soap and water after use. Wash hands before touching eyes or face and prior to using washroom. Store in a cool area away from heat and light. Do not smoke or eat while applying. Application of Critter Ridder is not known to harm ornamental plants. DO NOT USE ON FOOD OR EDIBLE PLANTS, OR WHERE CHILDREN WILL PLAY.

FIRST AID: If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for

treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Do not reuse container. Wrap empty container in newspaper and place in household garbage.

GENERAL INFORMATION: Critter Ridder contains ingredients that irritate animals when they touch or taste the product. It can be used to repel animals such as dogs, cats, groundhogs, skunks and raccoons from treated areas for about 30 days.

DIRECTIONS FOR USE:

INDOORS: Spread at a rate of 83 g/m²
(about 100 mL/m²) on areas to be protected.

Repeat application after 30 days, if needed. A 250 g package will treat about 3 m². OR A 500 g product will treat about 6 m². OR A 1 Kg package will treat about 12 m².

OUTDOORS: Apply on sunny, dry days. Spread by hand (gloves are recommended) or using manual or motorized spreaders at a rate of about 117g/m² or about 125 mL product/m². May be applied to lawns, garden paths and flower beds. To protect particular sites, such as garbage bags, ornamental plants, trees or buildings (e.g., garages, verandas, sheds) apply on the ground as a protective band 0.5 m for skunks, 2 m for racoons, 0.3 m for groundhogs, 0.5 m for dogs and 0.3 m for cats. Repeat applications after 30 days, if needed. A 250 g package will treat approximately 2.125 m². OR A 500 g package will treat approximately 4.25 m² OR A 1 Kg package will treat approximately 8.5 m².
