Repeat application after 30 days, if needed. A 250 g package will treat about 3 m<sub>2</sub>. OR A 500 g product will treat about 6 m<sub>2</sub>. OR A 1 Kg package will treat about 12 m<sub>2</sub>. OUTDOORS: Apply on sunny, dry days. Spread by hand (gloves are recommended) or using manual or motorized spreaders at a rate of about 117g/m<sub>2</sub> or about 125 mL product/m<sub>2</sub>. May be applied to lawns, garden paths and flower beds. To protect particular sites, such as garbage bags, ornamental plants, trees or buildings (e.g., garages, verandas, sheds) apply on the ground as a protective band 0.5 m for skunks, 2 m for racoons, 0.3 m for groundhogs, 0.5 m for dogs and 0.3 m for cats. Repeat applications after 30 days, if needed. A 250 g package will treat approximately 2.125 m<sub>2</sub>. OR A 500 g package will treat approximately 4.25 m<sub>2</sub>OR A 1 Kg package will treat approximately 8.5 m<sub>2</sub>.
