This insecticide contains the active ingredient spinosad which is derived from a naturally occurring bacterium, *Saccharopolyspora spinosa*. Ants are attracted by the bait and carry it to their nest where it is fed to other worker ants, larvae and the queen. The colony is controlled within 1 to 2 weeks. Kills ants, including carpenter ants.

USE SITES:

OUTDOOR AREAS: ornamental landscaped areas (such as in residential areas and parks), turf (such as lawns, athletic fields, recreational areas, golf courses, commercial turf, sod, grass buffers, parks, playgrounds, cemeteries, picnic areas and campgrounds), crop areas (food and feed), gardens and fallow lands.

RESIDENTIAL, INSTITUTIONAL, COMMERCIAL, AND INDUSTRIAL AREAS: Use in and around single and multi-family residential buildings, institutional, commercial and industrial facilities (such as schools, hospitals, warehouses, apartments, supermarkets, restaurants, kitchens, motels, hotels, processing facilities/plants, barns, livestock dwellings, and railyards), on or around decks, patios, balconies, paths, electrical conduits, vents, pipe chases, concrete slabs, crawlspaces, skylights on roofs, garbage cans, around and behind appliances, along walls, window sills, sidewalks, and driveways; on ground around home or structure, and other areas ants are found.

DIRECTIONS FOR USE:

1. To open the bait station, place on a flat surface with the cone facing up. If the cone is filled with liquid, move station from side to side rapidly until there is no liquid in the cone. With scissors, cut the top of the cone so that the top of the cone is level with the top of the rest of the bait station. Place bait station where ants are found.
2. Place bait stations 1.5 to 3 metres apart and use up to 4 bait stations per 15m² if ant infestations are low to moderate. For severe infestations use up to 9 bait stations per 15 m².
3. Place the station near ant nest or where ants are visible. Avoid placing in direct sun to decrease evaporation of the bait solution
4. Check station regularly, and replace when bait solution has been consumed or dried out
5. Once ants are controlled, replace bait stations every three months to prevent new infestations.

6. Alternatively, when ant nest is controlled, remove and dispose of according to the Storage and Disposal instructions.

7. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not try to open the STATION. Keep and place bait stations in areas inaccessible to children and pets.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 - 20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

ENVIRONMENTAL HAZARDS: Toxic to aquatic organisms.

STORAGE: To prevent contamination, store this product away from food or feed.

DISPOSAL: Make empty container unsuitable for further use. Dispose of empty container in accordance with provincial requirements.
