## **DIRECTIONS FOR USE:**

### **How to Apply:**

DO NOT apply as a space spray or broadcast application. ONLY spot or crack and crevice applications are permitted. Spot treatment is localized to surface area not more than 0.2 m<sup>2</sup>. Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

### **Restrictions:**

- DO NOT apply to any body of water.
- DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
- Avoid application of this product when winds are gusty.
- DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed.
- Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment.
- DO NOT apply when people, pets or livestock are present.
- DO NOT allow people, pets or livestock to enter treated areas until sprays have dried.
- DO NOT allow spray to drip or allow drift onto non-target surfaces.
- DO NOT apply to people, pets, livestock or sources of electricity.
- DO NOT apply to furniture, mattresses, linens, toys, or clothing.
- DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces, small storage rooms, closets indoors and eaves and soffits outdoors).
- When applied indoors, ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air.
- When applied outdoors, DO NOT apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs).
- DO NOT apply as a space spray or broadcast application.

**GENERAL DIRECTIONS:** SHAKE CAN WELL BEFORE USING. Test a small inconspicuous area for color fastness & staining before full application. Hold container approximately 30 cm from surface being sprayed and spray until wet. Cover fish bowls when spraying.

### **Indoor Use:**

#### **To Kill Ants, Carpet Beetles, Cockroaches, Crickets, Earwigs, Millipedes, Sowbugs, Spiders and Silverfish:**

Thoroughly treat indoor building surfaces in hard to reach places areas including, cracks, crevices in walls, floors and ceilings; along and behind baseboards; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., shelves, drawers, cabinets and storage units); around garbage containers; localized areas of floors and floor coverings; and points of entry (e.g., around windows and doors). Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

#### **To Kill American & Brown Dog Ticks and Dog & Cat Fleas:**

DO NOT SPRAY PETS WITH THIS PRODUCT. Only treat pets with products specifically registered for use on that type of pet. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To Kill Spiders, Sowbugs, Earwigs, Cockroaches, Crickets, Ants, (Dog and Cat) Fleas, American Dog and Brown Dog Ticks, Millipedes, House Flies And Cluster Flies:

For use outdoors on the exterior surfaces of buildings, garbage cans and on patios, porches and decks as a spot treatment. Apply to the outside surfaces of foundations, light fixtures, eave troughs and under eaves and places where listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of patios, porches and decks. DO NOT treat soil, turf or other plants adjacent to the treatment site. House flies and cluster flies will be killed when they land and crawl on the treated surfaces. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin, or clothing. DO NOT USE ON ANIMAL FEED AREAS. May cause skin and/or eye irritation. Contents under pressure. Do not place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50°C.

**FIRST AID:** If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.
