Avoid contact with eyes, skin and clothing. Do not allow adults, children or pets in treatment areas during application. Wash immediately after using this product.

Wear long-sleeved shirt, long pants, chemical-resistant gloves, shoes plus socks during loading, application, clean-up and repair.

DO NOT apply by air.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Toxic to aquatic organisms.

Toxic to bees and certain beneficial insects.

To reduce runoff from treated areas into aquatic habitats avoid application to areas with a moderate to steep slope, compacted soil, or clay.

Avoid application when heavy rain is forecast.

Contamination of aquatic areas as a result of runoff may be reduced by including a vegetative strip between the treated area and the edge of the water body.

STORAGE:

To prevent contamination store this product away from food and feed.

DISPOSAL:

Recyclable containers

DO NOT reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

Returnable containers

DO NOT reuse this container for any purpose. For disposal, this empty container may be returned to the point of purchase (distributor/dealer).

Refillable containers

For disposal, this container may be returned to the point of purchase (distributor/dealer). It must be refilled by the distributor/dealer with the same product. Do not reuse this container for any other purpose.

DIRECTIONS FOR USE:

PESTS: kills ants, controls black cutworm and earwigs

USE SITES: Residential yards and ornamental gardens, lawns, golf courses, residential and commercial landscaping, hotel and motel landscaping, parks, athletic fields, school yards, perimeter treatments of commercial, agricultural and industrial buildings.

APPLICATION DIRECTIONS

To kill ants: Apply bait at 6 – 45 kg per hectare (0.6 – 4.5 grams per square metre). Scatter the bait on ant trails and around ant nests or mounds and the soil around or near the plants to be protected. Bait can be placed in a ring around the base of individual plants, seedlings and trees. For homes and other structures, ornamental gardens, and landscaped areas, scatter the bait in a perimeter around the area to be protected. In outdoor containers, scatter the bait in the pots of plants being damaged or around pots. On lawns, broadcast bait over area where ants occur.

To control black cutworm: Apply at 25-50 kg/ha (0.25-0.50 kg/100 m²). Scatter the bait on the soil around ornamental seedlings. For outdoor ornamentals in containers, scatter the bait in the pots of seedlings to be protected. On lawns, broadcast bait over area where black cutworms occur.

To control earwigs: Apply at 25-50 kg/ha (2.5-5.0 g/m²). Broadcast the bait on the soil near the base of the seedlings or in containers of outdoor ornamental seedlings. On lawns, broadcast bait over area where earwigs occur. Apply at the higher rate when earwig pressure is expected to be high. Reapply after heavy rain or watering. Reapply as the bait is consumed or every 4 weeks.

Apply at the higher rate if the infestation is severe.

Reapply after heavy rain or watering.

Reapply as the bait is consumed or every 4 weeks. Do not make more than four applications per year.

- Apply by hand (hand dispersal, spoon, cup, or shaker), or by manually or power operated spreaders (gravity or rotary) suitable for granular products can be used to ensure uniform coverage. Do not use food utensils such as tablespoons, cups, etc. for food purposes after pesticide use .
- The product works best when soil is moist but with little or no standing water.
- Bait may be placed directly on ant hills and trails.
- Do not place in piles.

As this product is not registered for the control of pests in aquatic systems, **DO NOT** use to control aquatic pests.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT apply by air.

DO NOT allow effluent or runoff from greenhouses containing this product to enter lakes, streams, ponds or other waters.

NOTICE TO USER: This pest control product is to be used only in accordance with the directions on the label. It is an offence under the Pest Control Products Act to use this product in a way that is inconsistent with the directions on the label.
