Seclira® WSG insecticide (water soluble granule) gives you the power and flexibility to provide long-lasting control of ants, cockroaches, fleas, house flies, brown marmorated stink bugs and more at the source.

- Suitable for a wide range of situations and sites, both indoor and outdoor, including residential, barns and commercial kitchens
- Controls pyrethroid resistant bed bugs and provides residual control of a broad spectrum of unwanted pests such as ants and spiders
- Economical spray for larger areas with a short re-entry interval

Animal housing (including beef barns, calf hutches, calving pens, dairy areas and barns, dog kennels, hog barns, horse barns, milk rooms, poultry barns and houses, rabbit hutches); buildings at campgrounds; clinics; garbage or refuse bins and receptacles; grain mills; granaries; food/feed handling establishments; homes; hospitals; hotels; institutions; laboratories, mausoleums; mobile homes; motels; nursing homes; office buildings; schools, nurseries and daycare centers; stores; storage buildings; theme parks; transportation equipment (e.g. aircraft (cargo areas only), buses, boats, ships, trains, trailers and trucks); utilities; warehouses; in and around commercial, industrial, livestock and residential buildings

Non-food/feed areas: garbage rooms, restrooms, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling) and serving areas when no food/feed is present

Food/feed areas: areas for receiving, storing, packing (e.g. canning, bottling, wrapping, boxing) and preparing food/feed, edible waste storage and enclosed processing systems (e.g. mills, dairies, edible oils, syrups). Serving areas (when food/feed is exposed and facility is in operation) are also considered food/feed areas.

Pests controlled

Ants (excluding Pharaoh), Asian lady beetles, bed bugs, brown marmorated stink bugs, centipedes, crickets, cockroaches (American and German), earwigs, fleas, house flies, millipedes, paper wasps, pillbugs, sowbugs, spiders, springtails, stored product beetle pests (confused flour beetle, granary weevil, lesser grain borer and warehouse beetle), yellow jackets

Directions for use

Crack and Crevice Treatment: Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

Spot Treatment: Spot application is localized to a surface area not more than 0.2 m². Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room.

Void Treatment: An application into inaccessible, enclosed empty spaces of a structure. For example, hollow walls and suspended ceilings.

Indoor Perimeter Treatment: Indoor perimeter application is less than 0.3 m wide along the edges of a room to baseboards, wall-floor and ceiling-wall joints, and around doorways or windows.

House Fly Treatment: Apply to outside surfaces of screens, doors, window frames, in garages, or wherever flies enter or congregate around or on the building, directly contacting flies. Application sites include inside and outside surfaces of dumpsters, other trash-holding containers and surrounding surfaces, directly contacting flies.

Exterior Structural Applications: Apply where pests rest, trail and harbor, such as structural and other voids (including voids associated with and around doors, windows, utility entry points, behind siding and weep holes), eaves of structures, around lights or other insect attractant areas, garbage receptacles.

Application instructions

- Apply to structural surfaces where listed pests are found, may hide or may enter the structure
- Apply directly to listed pests where possible
- This product may be re-applied after 10 days if pests continue to be a problem

See label for pest specific instructions for indoor and limited outdoor treatments.

Application tips

Although typically nonstaining, treat a small, inconspicuous area of the surface to ensure there are no adverse effects such as staining or discolouration before making a full-scale application to a surface.

Resistance management

Where possible, rotate the use of Seclira WSG insecticide or other Group 4 insecticides with different groups that control the same pests in a location.
